## **Rating and Vetting Program**

The KCRCC has developed a process of informing local voters about candidates running for both partisan and non-partisan offices. We have found that some candidates who subscribe to be Republicans do not necessarily hold strong Republican values. Furthermore, Precinct Committeemen are frequently asked for information about candidates and issues. The Precinct Committeemen's job is to know their constituents and to keep them informed about candidates and ballot measures.

For this reason, the KCRCC has implemented a Rating and Vetting

Program whereby candidates are rated by the Precinct Committeemen.

## **FOR CANDIDATES:**

## **Rating Criteria:**

We will be searching for and rating men and women of good character, virtue and integrity, and who hold constitutional and traditional values.

The KCRCC encourages candidates to participate in this process and other opportunities to present themselves to the voters such as forums, town halls, social media, speaking before the KRCC, and "Meet and Greets."

Tell us a little about yourself and your family, how long you have lived in the area and your occupation.

- **Step 3. Meet with Recruitment Committee (not required of incumbents)**
- Step 4. Interviewed by Rating and Vetting Committee
- Step 5. Send headshot photo to <a href="mailto:info@kcrcc.com">info@kcrcc.com</a>. List your name and office
- Step 6. Attend optional Meet and Greet before Central Committee Meeting
  July 25 OR August 22 5:45 pm to 6:45 pm. Which meeting assigned by KCRCC
- Step 7. File Candidate Petitions by SEPTEMBER 8 @ 5 pm. September 7<sup>th</sup> recommended Questionnaires will be posted on KCRCC website after September 8th
- Step 8. Special Central Committee meeting for Recommending Candidates on 9/14
- Step 9. Campaign Committee meets with Recommended Candidates on Sept 21.

Will discuss your campaign and yard signs, rack cards, magnetic signs, and etc.

Central Committee will NOT give campaigns donations nor run your campaign.

- Step 10. Withdrawal date is September 22<sup>nd</sup>
- Step 11. October 6<sup>th</sup> Bag stuffing 4:30 pm. Candidates rack cards MUST be there by 3:30 pm. Those arriving after 3:30 pm WILL NOT be placed in bags already filled.
- Step 12. Walk precincts, speak at Republican clubs, and campaign until November 7th
- Step 13. November 8th celebrate your victory.
